

**SUBSTITUTE FOR
HOUSE BILL NO. 4700**

A bill to amend 1998 PA 58, entitled
"Michigan liquor control code of 1998,"
by amending section 107 (MCL 436.1107), as amended by 2021 PA 19.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 107. (1) "Cash" means money in hand, bank notes, demand
2 deposits at a bank, or legal tender, that a creditor must accept
3 according to law. Cash does not include call loans, postdated
4 checks, or promissory notes.

5 ~~(2) "Class C license" means a place licensed to sell at retail~~
6 ~~beer, wine, mixed spirit drink, and spirits for consumption on the~~
7 ~~premises.~~

8 (2) "Church" means an entire house or structure set apart
9 primarily for use for purposes of public worship, that is tax

1 exempt under the laws of this state, and in which religious
2 services are held with which a clergyman is associated, and the
3 entire structure of which is kept for that use and not put to any
4 other use inconsistent with that use.

5 (3) "Class A hotel" means a hotel licensed by the commission
6 to sell beer, wine, and mixed spirit drink for consumption on the
7 premises only that provides for the rental of, and maintains the
8 availability for rental of, 20 or more rooms.

9 (4) "Class B hotel" means a hotel licensed by the commission
10 to sell beer, wine, mixed spirit drink, and spirits for consumption
11 on the premises only that provides for the rental of, and maintains
12 the availability for rental of, 20 or more rooms.

13 (5) "Class C license" means a place licensed to sell at retail
14 beer, wine, mixed spirit drink, and spirits for consumption on the
15 premises.

16 (6) ~~(3)~~—"Class G-1 license" means a place licensed to sell at
17 retail beer, wine, mixed spirit drink, and spirits for consumption
18 on the premises at a golf course having at least 18 holes that
19 measure at least 5,000 yards and which license is issued only to a
20 facility that permits member access by means of payments that
21 include annual paid membership fees.

22 (7) ~~(4)~~—"Class G-2 license" means a place licensed to sell at
23 retail beer, wine, and mixed spirit drink for consumption on the
24 premises at a golf course having at least 18 holes that measure at
25 least 5,000 yards and which license is issued only to a facility
26 that permits member access by means of payments that include annual
27 paid membership fees.

28 (8) ~~(5)~~—"Club" means a nonprofit association, whether
29 incorporated or unincorporated, organized for the promotion of some

common purpose, the object of which is owning, hiring, or leasing a building, or space in a building, of an extent and character as in the judgment of the commission may be suitable and adequate for the reasonable and comfortable use and accommodation of its members and their guests, but does not include an association organized for a commercial or business purpose.

(9) ~~(6)~~ "Commission" means the liquor control commission created in section 209.

~~(7) "Church" means an entire house or structure set apart primarily for use for purposes of public worship, and that is tax exempt under the laws of this state, and in which religious services are held and with which a clergyman is associated, and the entire structure of which is kept for that use and not put to any other use inconsistent with that use.~~

(10) ~~(8)~~ "Distiller" means a person licensed to manufacture and sell spirits or alcohol, or both, of any kind.

(11) "Financial records" means any document or summary of information contained in a document, including electronic documents, that contains information about the financial activities or position of a person, including, but not limited to, information about the person's assets, balance sheets, budgets, cash flow, earnings, revenue, expenditures, income, investments, losses, liabilities, payroll, profits, retained earnings, or taxes.

(12) ~~(9)~~ "Hotel" means a building or group of buildings located on the same or adjoining pieces of real property, that provide lodging to travelers and temporary residents and that may also provide food service and other goods and services to registered guests and to the public.

~~(10) "Class A hotel" means a hotel licensed by the commission~~

21 (13) "License" means a contract between the commission and the
22 licensee granting authority to that licensee to manufacture and
23 sell, sell, or warehouse alcoholic liquor in the manner provided by
24 this act.
